Page 31. Review object graph. Q are O10 and O07 reversed in dependency? Does dependency mean procedural dependency?

If an attribute is optional, but the class we have it in is 0:1 or 0:N, might it be required in the class? No xsd to confirm, so please review in class diagram. E.g., Required Credential Level, p. 54, contains a SET.

Page 54. The AgencyEmergencyMedicalServicesCertification list is a list of all state-recognized certifications (DConfiguration.02), irrespective of which ones the agency has. It should be attached to the Jurisdiction or to the AgencyIdentifier, which should be renamed AgencyJurisdiction.

Page 54. Should AgencyEmergencyMedicalDispatchVendor should be associated with Agency identifier (AgencyJurisdiction) rather than agency, or with AgencyServiceArea, which contains the EMDCoverageCode attribute)?

Page 54. Is EMD the same as dispatch? Will any personnel be dispatched to areas that do not have EMD?

Page 54. Should URL should be part of agency rather than contact?

Page 76. degreeSubjectCode (0:*) and HighestDegreeCode (:1) are AgencyProfessional attributes. Should they be associated?

Page 76. There is a credential level code in Credential and in Employment. Should the relationship between Employment and Employee go through the credential?

Page 76. Should driver's license be in the Credential class?

Page 76. Should EMS Service Duration be on Professional rather than Employment?

Page 85. Should we move agencyvehicle.usageCategoryCode from agencyvehicle to agencyvehiclecrew, with assumption that a physical vehicle may serve different types of call, and that the crew profile is for a particular usage?

Page 102: Should "medical necessity indicator" be moved from Billing to Transport, with the other authorization metadata? Or could it even be derived from that metadata?
