It is significant due to the need for a medication list which contains not only a summary, but the details of a patient's medication history (prescribed medication, dispensed medication, etc.). It's importance is confirmed by the fact that it is taken up by the Austrian e-Medication project and Geneva SMTL project

Significant Deployment Activity:

- **European Large scale pilot project "epSOS"**, pilot phase, using a specification 90% similar to PRE and DIS profiles. The epSOS project has finished in June 2014, but epSOS infrastructures are still in use in some countries. The follow-up projects to epSOS, such as EXPAND, build on top of the epSOS specifications.
- Austrian National Health Record (ELGA): The specification of the nation-wide Austrian e-Medication project is currently set to be fully based on IHE Pharmacy profiles: CMPD, PRE, DIS, PADV and PML.
 Specification has been started 2013 and shall be finished in end of 2014. Implementation planned for 2015. Nation-wide rollout starts Jan 2016.
- Saudi e-Health Exchange platform (SeHE): The specification of the nation-wide Saudi-Arabian e-Prescription/e-Dispensation project is currently set to be fully based on IHE Pharmacy profiles: CMPD, PRE, DIS, PADV. Specification has been started 2013 and shall be finished in end of 2014.
- **SMTL** project in Geneva/Switzerland ("shared medication treatment list") leveraging the Pharmacy Medication List (PML) profile
