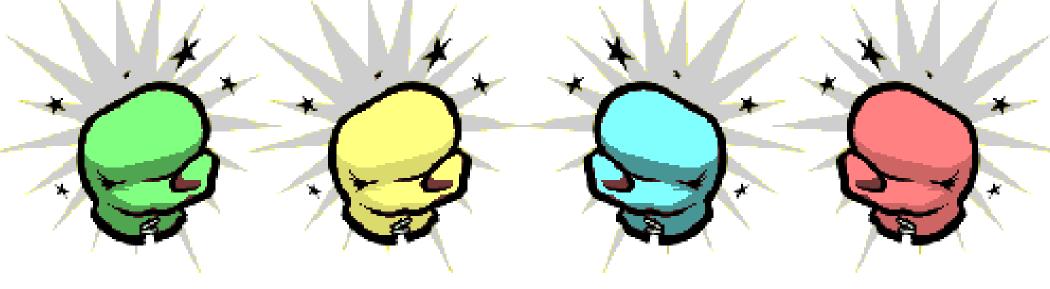

Future Goals for RIMBAA WG from Vancouver WGM sept 2008

- Marketing Public exposure of successes
- Sharing of experiences and solutions
 - e.g. RP/RO more future-proof than MP/MO
- Education for newbies to RIMBAA
- Make vocab committee aware that OID changes, code removals, are very problematic for RIMBAA applications
- RIM was created with a messaging-mindset. If one views the RIM from an OLTP or DataWarehouse perspective, is there a delta, i.e. are there things that should be changed?
- Connectathon for exchange of data between RIMBAA applications
- Publish informative document best practices going from persistence layer to message/document.

A brainstorm type discussion about how RIMBAA applications fit within the HL7 SAEAF framework

- RIMBAA is a bit of an oddball implementers group, working on an area that's historically outside of the scope of HL7.. but is it really? It uses the products of the HDF like any of the supported "interoperability paradigms" - it'll be interesting to discuss the implications of including it within the scope of HL7 and its architecture framework.
- Should RIMBAA be part of the architecture framework? Is it already part of the framework?
- Should HL7 change its mission to be about application architectures? Why, or why not?

- Role of DCM and Templates in RIMBAA and SOA
- Can we create a SOA Common Information Model?
 - Michael vd Zel: We (UMCG) use something very similar to Clinical Document R-MIM, only with multiple entry points, more from the Clinical Statement, ergo DIM. Are there harmonisation efforts to update the Clinical Statement part of the Clinical Document with the Clinical Statement work done in PatientCare or StructDoc.

- Schema improvement project 2008NE (March?)
 - XML Binding Frameworks
- Have classes/CMETs extend each other. E.g. Observation extends Act, PatientLite extend PatientIdentified etc.
- Make this a joined effort with Xml schema enhancement initiative
