PS 1.2 CC#1-4

- 1. The system **SHALL** provide the ability to capture demographic information as discrete data as part of the patient record.
- 2. The system **SHALL** provide the ability to maintain demographic information as discrete data as part of the patient record.
- 3. The system **SHALL** provide the ability to render demographic information as discrete data as part of the patient record.
- t. The system **SHALL** provide the ability to manage historic information for demographic data including programmes, addresses, phone numbers and email addresses.

CP.1.8 CC#1-2

- 1. The system **SHALL** provide the ability to manage patient preferences (e.g., language(s), religion, spiritual and cultural practices).
- 2. The system **SHALL** provide the ability to manage family preferences (e.g., language(s), religion, spiritual and cultural practices).

CPS.1.2 CC#9

9. The system **SHALL** provide the ability to capture the patient's gender used for administrative purposes (as distinct from the clinical gender).

CPS.1.2 CC#13

13. The system **SHALL** provide the ability to manage the date/time of birth, down to the minute, according to scope of practice, organizational policy and/or jurisdictional law.

CP.9.2 CC#3

3. IF the patient is tagged as deceased THEN the system MAY provide the ability to capture (i.e., trigger) and render the collection of death certificate data.

CP 4 4 CC#11

11. The system **SHOULD** capture and render complete demographic information for diagnostic orders according to scope of practice, organizational policy and/or jurisdictional law.

RI.1.1.1 CC#1-2

- 1. The system **SHALL** provide the ability to capture (originate) a Record Entry instance corresponding to an Action instance and context.
- 2. The system SHALL capture a unique instance identifier for each Record Entry.

RI.1.1.2 CC#

1. The system **SHALL** provide the ability to update (amend) Record Entry content.

RI.1.1.5 ????

Experiences / Challenges / Questions Functions List

- For demographics, easy to update existing list of functions just basic grunt work.
 - Will get more difficult as we move into clinical functions.
- Did not look for potential new functions in R2
 2013 that could be added to the MU profile.
 - Do we want to do this or leave to the other parallel stream of work since they have the EA tool and possible comparison functionality?

Experiences / Challenges / Questions Conformance Criteria

- When updating the CC the excel cell size became a challenge.
 Required copy/paste to Word using the HTML format
- In the spreadsheet the 2012 CC are combined. This makes it tedious and time consuming to do a comparison with the 2013
 - Is there a document where they are not combined?
- Did not look for potential new CC for each function
 - Do we want to do this or leave for other parallel stream of work?
- Are there other file formats so a quick document compare can be done between 2012 and 2013? This would make it easier to scan through new items for potential addition

Planning & Moving Forward Discussion

- Is the parallel approach the right approach?
- Do we wait until the EHR-S FM R2 is complete/published?
- Can we do the ONC and the EHR-S FM mapping work at the same time or will this cause re-work?
- How do we use the new EA tool? Just for stream 2? Does it have version control and release comparison functions?
- Typical project questions
 - When is this required?
 - Initial target: by Cambridge WGM, we should try to have a version of MU-FP ready for prime-time show-n-tell!
 - How can we split this up and with whom?
 - Need lead, clinical expertise, tooling expertise.
