Minutes of 9 October teleconference were approved without objection.

3) Report on EHR Lifecycle Model

Last Tuesday the EHR TC approved the EHR Lifecycle Model for ballot as a Draft Standard for Trial Use, intended for the December 2007 ballot cycle. Final consultations are underway with the submitters of public comments and the reconciliation is almost complete. A reconciliation summary will be circulated in the next several days.

Next week we will approve the reconciliation items on the EHR Interop teleconference. We will then request approval from the full EHR TC (on the subsequent teleconference). The EHR/LM will then be revised accordingly, posted and sent to the EHR TC Publications Work Group for their review and preparation for ballot.

## 4) Report on CDAr2 Reference Profile for EHR Interoperability

The EHR TC approved the CDAr2 Reference Profile for DSTU ballot, also in the December cycle. We will continue consultation with Calvin Beebe (Mayo Clinic and Co-Chair of the HL7 Structured Documents TC) to finalize the ballot draft. It will be posted when available.

## 5) Report on first ONC/AHIC/HITSP Use Case alignment draft

Our first draft (Chapter 1) details alignment of the Year 1 Care Delivery (EHR/Lab Results Reporting) Use Case with the HL7 EHR/PHR Models. Sherry Selover led the team developing this draft. The EHR TC has also agreed to submit the Chapter 1 Draft and its referenced Models to the ANSI HITSP Foundations Committee, for consideration of how this might guide future HITSP standards harmonization efforts.
