- 2) The group reviewed the spreadsheet of W5 mappings from current adverse event and patient safety standards
- 3) It was noted that this work has been done before and Elaine asked that any previous mappings be provided as references. Mead noted that he had mappings from work with ICSR. It was also noted that CIOMS is now electronic. It was also suggested that the condition resource be consulted as a potential framework for the adverse event resource.
- 4) The group then discussed the need for use cases and storyboards to help frame the scope of this resource. Elaine will collect a series of short use cases for the next meeting.
- 5) The group then reviewed the FHIR proposed event pattern there is some question about the adverse event resource following the proposed pattern which is predicated on workflow that pairs an event with a request or order.
- 6) The next meeting will occur on Friday, October 21 at 10 AM ET.

Outstanding Questions

Questions and comments from the FHIR Management Group (FMG) related to FHIR AdverseEvent Resource:

- 1) The scope should include events that happen to individual other than patients.
 - a) Specifically, Practitioners and RelatedPersons
 - b) Possibly also Devices (e.g. equipment damage)
- 2) Timeline should be updated to inclusion in DSTU 3 rather than 2.1.
 - a) 2.1 would have been tight anyhow. Deadline is early July 2016 to have your resource at DSTU-level quality

- 3) For each of the "related resources", can you define what the nature of the relationship is?
 - a) Reference by name links
 - b) Patient resource
 - c) Observation resource
 - d) Medication resources
 - e) Immunizations
 - f) Devices
- 4) Need to correct and update resource proposal and let Lloyd know.
